# Rental Agreement

## OWNER RESPONSIBILITIES

We are not responsible for accidents or injuries to guests or for loss of money, jewelry, or other valuables during their stay. While we make every effort to ensure our guests' stay is enjoyable, we are not responsible for incidents beyond our control, including, but not limited to weather conditions.

# RENTER RESPONSIBILITIES

I am at least 25 years of age. I understand my responsibilities as renter and occupant. I accept financial responsibility for any loss or damages to the property caused by me, or any member of my party. I agree to pay the owners for the replacement or repairs of lost or damaged property caused by us during our stay.

## **GUESTS**

The number of overnight guests allowed is the number of people stated on the reservation,12 persons maximum. Other than baby cribs, no other beds may be brought into the home. No guest may assign this agreement or sublet use of any part of the house.

#### CHECK-IN

Check-in is at 3 pm. We may be able to accommodate earlier arrivals subject to a \$20 per hour fee. As soon as possible, please confirm your arrival time with us. Our property manager will give you house keys and provide further information about our home and the area.

## **CHECK-OUT**

Checkout is at 11 am. We may be able to accommodate later departures subject to a \$20 per hour fee. All keys must be returned before leaving. Renters agree to pay \$25 for each set of keys not returned.

#### **PAYMENT**

An initial deposit payment of 50% of the total rent is required to make a reservation. The balance due, plus a \$200 refundable security deposit and \$95 cleaning fee is due 30 days prior to arrival. Security deposits will be refunded within seven days after departure if the premises are left in the same condition as upon arrival, and the terms of this agreement have been met.

#### **CANCELLATIONS**

In the event of a cancellation 60 days or more of the reserved dates, a full refund will be issued including any deposits and fees. Cancellations of 30 or more days of the reserved dates will result in a 50% refund of the total rent. Cancellations of less than 30 days of the reserved dates will result in 0% refund of the total rent.

Security deposits and cleaning fees will be refunded for any cancellation. Travel insurance is recommended to avoid cancellation fees.

#### WATER

All water in Playa Encanto is delivered by water trucks and pumped into each home's underground cistern. Renters will be provided with approximately 1,500 gallons of water, which should be more than enough for your stay. You should still conserve water to avoid running out. Cistern refills will be billed to the renter. Cistern water is NOT drinkable but perfectly ok for showering, washing dishes and cooking, if boiled. Bottled drinking water will be provided during your stay.

## **ELECTRICITY & PROPANE**

Our home uses propane for the oven and stove. All other appliances and lighting are powered by city electricity. Both sources of energy are expensive and must not be used unnecessarily or excessively. From July 1 to October 31, you will be provided with \$15 worth of power for every 24 hour period of your stay. During the remainder of the year you will be provided with \$7.50 worth of power for every 24 hours of your stay. This should be more than enough power for normal usage of the home. Power usage in excess of these amounts will be billed to the renter. Running the air conditioning with the doors and windows open is the most common excessive use of electricity.

#### **SMOKING**

Smoking is not allowed anywhere inside the house or on the terrace.

## **PETS**

Two pets maximum. There is a \$10 fee per animal per day. We are very pet friendly, however we require all pets to be domestic, house broken, and of an age and personality that they demonstrate no destructive behavior or excessive barking. Per Playa Encanto HOA rules, all dogs must be leashed when outside of the home. Please clean up after your pets at all times.

#### INTERNET

Our home is set up with free high speed wireless internet access. The router security code is 6E2797362F.

#### NOISE

All guests agree to keep noise to a minimum and be aware and respectful of our neighbors. Loud noise or music is not permitted after 10 pm. Under no circumstances may any loud parties or events take place at our home.

#### **FIREWORKS**

Fireworks of any kind are prohibited everywhere within Playa Encanto, including the beach.

# **OFF-ROAD VEHICLES**

Per Playa Encanto rules, guests are prohibited from using or bringing in off-road vehicles. All off-road vehicles must be parked outside of the guard gate.

# **INSPECTIONS**

The owners or owners' agent has the right to inspect the premises at anytime if there is reasonable cause to believe the renter or any other person is misusing or damaging the premises or furnishings therein.
